GENERAL DATA PROTECTION REGULATIONS (GDPR)

Angel Indoor Bowls Centre (the Club) has responsibility under the General Data Protection Regulations (GDPR) as to how it collects, stores and shares your personal data. ***'Personal data is defined as any piece of personal information that can be used to identify an individual, either directly or indirectly'.***

In addition, GDPR provides you as a member of the club the right to have copy of the personal data that the club stores, the right to ensure any personal data is accurate and the right to have any personal data deleted.

The Club's policy is not to share or disclose your personal data with any third parties unless you give specific consent. The personal data that you supply the club is only retained and used for the purpose of advancing bowling and associated activities. Personal data is stored on the Club's IT systems that can only be accessed by authorised individuals for legitimate purposes related to bowl's club business. The Club's Privacy Policy can be accessed on the Club's website.
