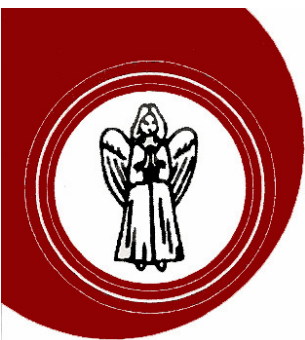

GENERAL DATA PROTECTION REGULATIONS (GDPR)

Angel Indoor Bowls Centre (the Club) has responsibility under the General Data Protection Regulations (GDPR) as to how it collects, stores and shares your personal data. ***'Personal data is defined as any piece of personal information that can be used to identify an individual, either directly or indirectly'***.
