From the Board.

Locker Fees

This month has indeed posed significant challenges for the Board of Directors. We had to retract the proposed locker rental fee due to a legal threat from one of our members. Defending this action would have cost between £5K and £6K, which we believe is not a prudent use of your funds. We therefore offered a refund to those members who asked for it.

As of now, a few members have opted out and simply not paid the £5, and we have processed three refund requests. We are currently exploring how to best address the aging lockers, some of which are showing signs of wear. Several have required repairs including new locks at a cost of £33 each, with Keith Elliment generously offering his labour for free. Without his support, these repairs would place a strain on your club funds.

GDPR

As many of you are aware, I mistakenly sent the first batch of last month's newsletter using Cc instead of Bcc. This unintended oversight caused concern, prompting complaints, criticism and one enquiry to the Information Commissioner's Office.

I took immediate action, as I am legally required to do, informing those affected, writing a full report of the incident to the board, undertaking a risk assessment and a thorough review of our GDPR procedures, all done within 24 hours. Whilst this did not actually constitute a data breach as the email addresses were released to a closed group i.e. club members, who all signed an agreement on joining that their details could be shared with other members, I acted as though it were. I also recognized the need to strengthen our safeguards. One key area identified was the folder on the green steward's desk containing member details, which has now been secured in the office. Moving forward, to prevent similar issues, newsletters will no longer be emailed. Frankly, I'm not prepared to put myself in the firing line for a barrage of complaints and criticisms if I make a mistake. Instead, the newsletter will be available for members to download from our website, and printed copies, including larger print versions, will be accessible, as usual, in the club.

Club AGM

7.30pm on Friday November 28th November. For newer members, please be aware that this is the club AGM and not the bowling committee AGM which is held in April. The two events are very different. The club AGM is hosted by the board of directors and deals with the management of the club as a business and includes the presentation of audited accounts. The bowling committee AGM is hosted by the bowling committee and deals with all things related to bowling, such as competitions and leagues. Members of the Bowling Committee are proposed by the membership and voted to office at the AGM. As a limited company, and under the memorandum & articles of association, the existing board of Directors, may invite a member to join the board and on their first AGM stand for election. Existing directors decide whether or not to stand again after a 3 year term, retiring by rotation. If they decide to stay, then they have to be proposed and seconded at the AGM. Directors are usually invited for their skill set, knowledge, or business experience. For the purposes of further information the club structure is set out below:

- A. The club was formed as a limited company hence the name Angel (Tonbridge) Indoor Bowls Association Ltd (hereafter called the club). It was registered at Companies House and must abide by company law. At the same time it was registered with HMRC for the appropriate taxation. Annual accounts must be approved at the AGM and filed at Companies House and with the HMRC. It operates under the memorandum and articles of association in this name. A Council of Management (the board) was formed which is the board of directors

 The powers of the board are all encompassing and from this the following was created:
- **B. Committees (BC). Constitution and Rules** for the club were set up for the sub-committees with the object of organising bowling activities at the club and to further the game of indoor bowls. Obviously, some committees have merged but the objects remain. Alterations to the Constitution and Rules can only be made at the BC AGM and all resolutions are subject to the ratification by the board.
- **C. Byelaws.** The byelaws are approved by Angel (Tonbridge) Indoor Bowls Association Ltd Council of Management (the Board) under the powers conferred upon it and must be signed by the Company Secretary and displayed on the web site and notice boards. The Byelaws can be amended by the board at any time. Any proposals for amendments

A few statistics for you. Luke's team won with 150 points to H's 121. Obviously needs




to be a decider played at some point in the future when the knees, feet and sleep has been restored
